

## **Bad Boy Mowers “Hunt With an Attitude” Sweepstakes Official Rules**

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** Hunt With An Attitude (the “Sweepstakes”) is open only to legal residents of the 48 continental states of the United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Bad Boy Mowers and its parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. **3. Timing:** The Sweepstakes begins on July 4, 2020 at 12:00 a.m. Central Time (“CT”) and ends on November 26, 2020 at 11:59 p.m. CT (the “Promotion Period”). Administrator’s computer is the official time-keeping device for the Sweepstakes.

**4. How to Enter:** **(1)** During the Promotion Period, visit participating dealership and test drive a Bad Boy Zero Turn Mower. Dealership will then visit <http://badboymowers.com/huntwithanattitude> and complete and submit the registration form including a valid email address. You automatically will receive one (1) entry into the Sweepstakes. **Limit:** You may enter one (1) time during the Promotion Period. **(2) Mail:** To enter via this method of entry, hand print your complete name, address, city, state, zip code, telephone number and email address on a 3” x 5” card/paper, and mail in a first-class stamped envelope to: “Hunt With An Attitude” Sweepstakes, 102 Industrial Dr., Batesville, AR 72501, to be postmarked by November 26, 2020 and received by December 3, 2020, or will be forfeited. **Limit:** You may enter one (1) time during the Promotion Period. Limit one (1) entry per outer envelope. Multiple entrants are not permitted to share the same provided home address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different home addresses, identities, registrations and logins, or any other methods will void that entrant’s entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

**5. Prize Drawings:** Winners will be randomly drawn from among all eligible entries. All decisions of the Sponsor, and its sweepstakes administrators are final. In order for the selected winner to receive the sweepstakes prize, the entry details (i.e. name, email address, mailing address and dealership) must be confirmed by the Sponsor. Failure of the winner to confirm such information will result in another winner being drawn from among all eligible entries. Prizes will be fulfilled approximately 8-10 weeks after the conclusion of the Sweepstakes.

In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Disputes:** Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Arkansas or the appropriate Arkansas State Court located in Independence County, Arkansas; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
